#### Overview:

The Center for Fiction has connected writers and readers for over two hundred years. We encourage people to read and value fiction, and we support and celebrate its creation and enjoyment. We do this by providing access to books, supporting emerging writers, introducing children to contemporary books and authors through our KidsRead program, and nurturing diverse readers of all ages through our educational and public programs. In the past year, over 200,000 visitors came to us in person at The Center in Brooklyn, and almost 40,000 people participated in our programs. As a longtime home for readers and writers, we know that fiction expands our capacity for empathy and connection, and that sharing stories transforms communities.

We run a café & bar on our ground floor between our bookstore and event space. The cafe is intended as a source of revenue to support the mission work of the nonprofit, and as a service to our members and community. During the day, when not in use for programs, the café serves as a lively community space where writers work, kids read books, and friends catch up. In the evening, we serve patrons attending our events and classes. It is important that all the cafe staff are interested in the overall work of the cultural nonprofit, and actively encourage patrons to become more involved in the mission and programs. The cafe staff have significant daily interactions with our cafe regulars and members, and they are an important resource in gathering community feedback.

## **Job Description:**

In addition to full coffee/espresso service, the café features a selection of locally baked pastries, small bites, as well as beer, cocktails, wine and specialty non-alcoholic beverages. The barista/bartender should have a passion for delivering good customer service, and a willingness to develop and learn new skills.

Barista experience and **Food Handler's License** are strongly preferred.

## Responsibilities:

- Sell and serve all cafe items
  - Prepare coffee/espresso drinks and other beverages including alcoholic drinks
  - Prepare snacks and other food items
  - Use the register to calculate orders, prices, and perform transactions

- Count cash and tips at the beginning and end of each shift to ensure proper accounting
- Bartend program, rentals and specialty events as scheduled

#### Provide Customer Service

- Balance the need to be friendly to customers with the need to quickly get through lines of waiting customers
- Create a welcoming environment
- Maintain space cafe counter, auditorium, and downstairs public bathroom
  - Perform assigned side work such as cleaning, stocking, and food preparation throughout the day
  - Maintain a clean and healthy environment at the cafe counter to meet DOH standards
  - Maintain cleanliness standards and supplies in the public bathroom and report any significant issues to Operations team
  - Proactively ensure appropriate stock of items by reporting inventory needs to appropriate team member
  - Assist upon request in set up and take down of cafe and auditorium seating to accommodate programs, rentals and specialty events
  - o Perform opening and closing duties of the space: trash, securing the doors, etc.

- Ability to work collaboratively with other cafe staff and management
- Accurately represent the activities of the organization to customers and encourage greater participation in our programs, membership, and community events
